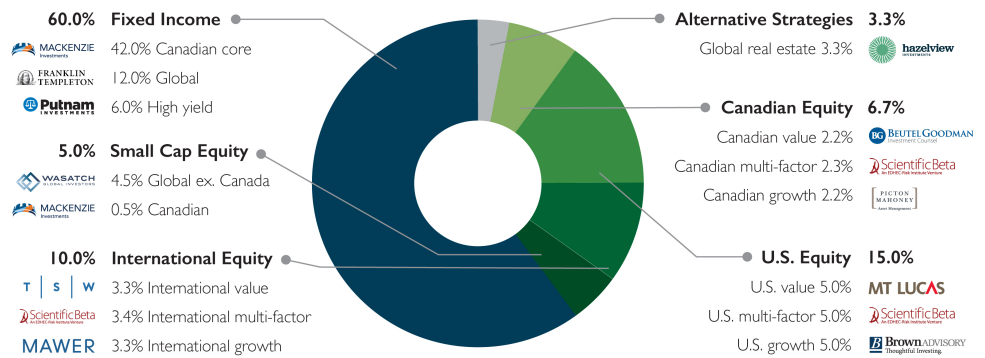

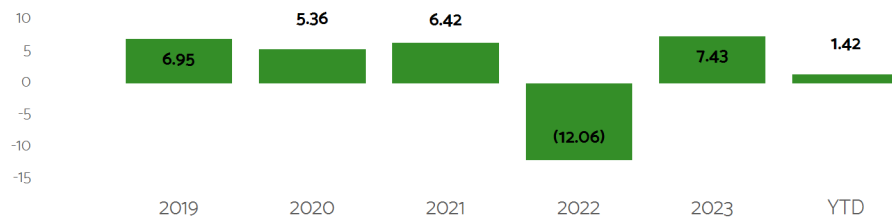
**Target Portfolio Allocation\***



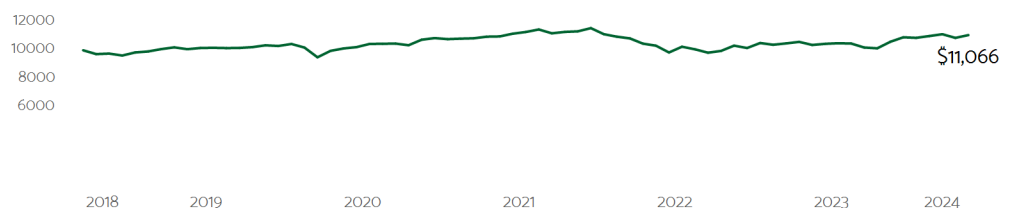

**Performance (%) Calendar Year Returns**

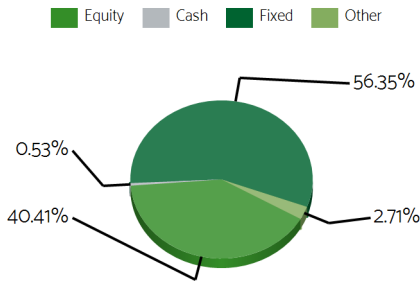


**Historical Performance (\$) Current Value of a \$10,000 Investment**

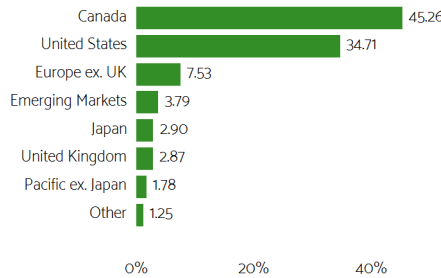


Your Portfolio Mix

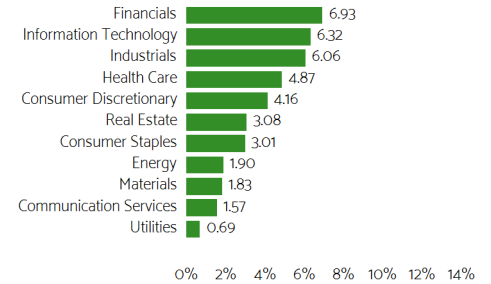
Asset Class Mix
